**WARNINGS**

- DILUTE WITH WATER BEFORE USE.
- ALLOW 7 DAYS BETWEEN LAST TREATMENT AND SLAUGHTER FOR HUMAN CONSUMPTION.
- No worm remedy, not even diluted Tramisol Concentrate, should be dosed to sheep and goats that have not been immunised against pulpy kidney (enterotoxaemia).
- In case of poisoning call a doctor and make this information available.
- Keep out of reach of uninformed persons, children and animals.
- Although this remedy has been extensively tested under a large variety of conditions, failure thereof may ensue as a result of a wide range of reasons. If this is suspected, seek veterinary advice and notify the registration holder.

DILUTE THE CONTENTS OF ONE 500 ml PACK WITH 4,5 l OF CLEAN WATER.  
AFTER DILUTION USE WITHIN 30 DAYS.

**Sheep and goats:** 3 ml/10 kg body mass.

**Cattle:** 15 ml/50 kg body mass.

**Ostriches:** 12 ml/10 kg body mass.
